PLEASE TAKE NOTICE, the Buffalo Creek Watershed District Board of Managers, Drainage Authority for the improvement of Branch P1 of Renville/Sibley/McLeod Judicial Ditch 15, will hold a public hearing at 2:00 p.m., on Wednesday, February 28, 2024, in the Government Services Center, 105 South 5th Street, Suite 116, Olivia, Mn 56214. The purpose of the hearing is to review the engineer's report to the drainage authority pursuant to Minn. Stat. § 103E.555 showing that the contract to construct the improvement of Branch P1 of Renville/Sibley/McLeod Judicial Ditch 15 is complete and recommending payment of additional damages, if any.
